RESEARCH ETHICS POLICY

The maintenance of the highest ethical standards in research is a requirement of the policy dealing with the code of ethics to check for misconduct and plagiarism in research and to maintain the public's faith in Arts and science.

RESEARCH ETHICS COMMITTEE

The Research committee of Edayathangudy G. S. Pillay Arts & Science College serves as the college's regulatory body, formulating policies, guidelines, and successfully addressing the institution's difficulties in order to advance research operations. Under the research committee of Edayathangudy G. S. Pillay Arts & Science College, a subcommittee known as the ethics committee offers advice and direction on research ethics.

1. Plagiarism

In a research paper, authors must write sentences in their own language. Beyond a brief phrase of six or seven words, word for word copying of another person's writing should be reported as a legal violation since it violates the copyright of the original author or publisher. URKUND Software is recommended to detect the plagiarised context.

2. Perversion of Information

Research findings should be published with enough supporting information based on relevant observations. The newspaper must also make note of the disappointing outcomes.

3. Rights to Access Data

The research information gathered during on-campus study is not the researcher's property rather it is property of the college. Research findings that can qualify for patent protection should be disclosed using an invention disclosure form. Each researcher owes it to the larger scientific community to contribute by sharing data.

4. Origination and Other Publication Matters

The results of the study must be made public for the benefit of other researchers. Only the researchers who have made contributions to the conceptual design, execution, and interpretation of the published one should be given authorship.

5. Duplicate and Clone Publication

Only one journal should be used for the publication of research findings. It is not advisable to submit the same data to several publications. Before submitting research papers to the journal, the researchers should ensure the originality of the journals and publishers.

6. Conflict of Interest

The findings of researchers from their research, especially any patentable discoveries, must be presented to their organisation before they depart.

7. Obligation to Report

All academicians should be collectively and solemnly diligent in reporting any suspicion of research misconduct.

8. Corrigendum

A correction occurred in the previous publication may also be treated as core part of research papers to rectify it
